### Financial Terms:

In considerations of a purchase price of \$\_\_\_\_\_, which includes the non-refundable / transferrable deposit of \$\_\_\_\_\_, which has been paid-in-full, for which this contract serves as a receipt, the seller transfers responsibilities associated with the ownership of the puppy listed and described above to Purchaser as of the date indicated on this agreement.

Puppy will be ready to leave for new home on: \_\_\_\_\_. If Buyer fails to take delivery of puppy on this date, a \$\_\_\_\_\_ per day food and board fee will be paid to the seller by the buyer until the puppy is delivered. In the event there is a delay in delivery on indicated date due to unavailability of veterinarian appointment for health check, flight delays or reschedules due to weather or any other unforeseen hinderance beyond the seller's control, buyer will not be liable for any food or board fee.

### One Year Health Guarantee:

This puppy is companion registered with the \_\_\_\_\_ and embodies the basic standards of the breed.

Puppy is current on vaccinations and dewormings at the time of sale and is microchipped for identification purposes. Buyer is strongly encouraged to register the microchip in their name with one of the National registries (i.e., AKC Reunite).

Seller guarantees puppy to be free of communicable viruses for 72 hours after the buyer receives the puppy. Seller guarantees the puppy to be free of any life threatening congenital defect for the first year of ownership. Buyer acknowledges that NO veterinary bill incurred by the buyer will be paid by the seller. There are no guarantees offered for this animal's training, size, marking, temperament, or hypo-allergenic status.

Non-life threatening ailments such as hypoglycemia, hernias, monorchidism, patella/hip or parasites are NOT covered by this guarantee, even though we have done our due diligence to breed and test parents against these ailments. This guarantee is non-transferable to ANY third party.

For ANY remedy from the seller of said puppy, Buyer must provide written veterinary confirmation to the Seller within 72 hours of veterinary diagnosis. If the claim is for the death, all documents from a licensed veterinarian, a formal necropsy, and cause of death will be sent to the seller, including microchip verification. If the claim occurs within the first year and the claim is valid, the puppy will be replaced with one of equal value and the same gender as the puppies are available, with the buyer being responsible for all transportation costs. Prior to replacement of the puppy, the original registration papers must be signed and returned to the Seller.

Buyer is encouraged to maintain the puppy's health with appropriate vaccinations and care specified by their veterinarian and will include heart worm and parasite preventative, good diet and a clean, safe healthy environment. Companion puppies are sold on a limited registration; show and breeding dogs will not be sold on this contract. Buyer is strongly encouraged to have their puppy spayed or neutered by 2 years of age.

### Payments and Charge Backs:

If the puppy is purchased thru a credit card, Buyer agrees that no charge back will be filled after arrival or pick up of said puppy. Buyer is responsible for all of Seller's expenses in the course of collection on a charge back transaction for the purchase price and the puppy.

### Limitations and Exclusions:

No other warranties or guarantees, expressed or implied, are made under this contract except as stated above. Any modifications to this agreement must be attached to this document and agreed upon by both the Seller and the Buyer, complete with signatures of all parties. Any disputes regarding said puppy, Buyer or Seller shall be settled only in Lincoln County in the State of Oklahoma.

All parties have read this agreement. All parties agree this is a legal and binding agreement.
